2022 HIGHLIGHTS



- This year at BLW we had a special graduation ceremony for our Los Niños Primero class. In addition to the current preschoolers graduating from our program, the inaugural class of Los Niños Primero graduated from high school!
- BLW served a total of 94 participants in our youth programs including Los Niños Primero, Elementary, and Teen.
- The BLW Food Pantry provided over 2,400 orders of food to households in the community.

- In addition to homework help and college prep, students in the Vera Court High School Program began taking field trips to local Madison events and cultural experiences. Some favorites included Concert on the Square and Taste of Madison!
- Vera Court served a total of 175 participants in our youth programs including Elementary, Middle School, and High School.
- We expanded our Legal Clinic to include more appointments. By increasing from one lawyer to three or four, we are able to more than triple the amount of appointments offered in 2021!

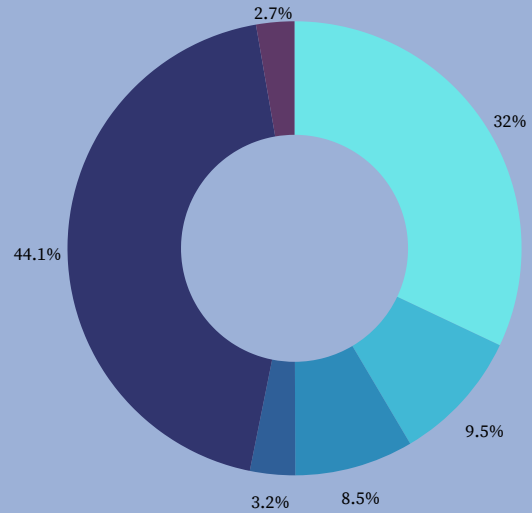

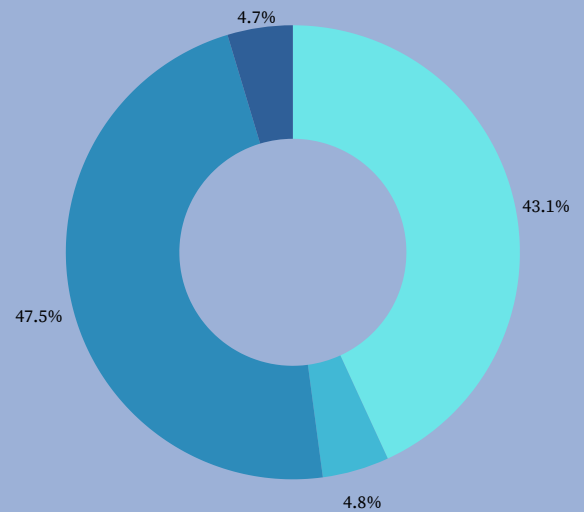
